**THE POOLE (TRAFFIC MANAGEMENT)
(DENMARK LANE) (AMENDMENT NUMBER 62) ORDER 2011**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	Denmark Lane	west side	from its junction with Denmark Road	for a distance of 106 metres in a northerly direction
ii	Denmark Lane	west side	from a point 136 metres north of its junction with Denmark Lane	to its northern extremity

B. The following shall be deleted from Schedule No. 8.18 (On Street Parking Place Waiting Limited to two hours, Mon-Fri 8am-6pm except permit holders) from the Order:

i.	Denmark Lane	west side	from a point 106 metres north of its junction with Denmark Road	to a point 136 metres north of that junction

C. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Denmark Lane	west side	total length

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Thirteenth Day of September of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Denmark Lane) (Amendment No. 62) Order 2011.
