

## BOROUGH OF POOLE

### THE POOLE (TRAFFIC MANAGEMENT) (MARIE CLOSE/CHLOE GARDENS) (AMENDMENT NUMBER 74) ORDER 2011

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

**A. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:**

i	Chloe Gardens	south side	from its junction with Marie Close	for a distance of 14 metres in a westerly direction
---	---------------	------------	------------------------------------	---

i.	Marie Close	east and south side	from a point opposite the common boundary of Nos. 2a and 3 Marie Close	to a point opposite the common boundary of Nos. 8 and 9 Marie Close.
ii	Marie Close	north-east side	from the common boundary of Nos. 8 and 9 Marie Close	for a distance of 30 metres in a north-westerly direction
iii	Marie Close	south side	from its junction with Chloe Gardens	for a distance of 10 metres in a westerly direction
iv	Marie Close	west and south side	from the common boundary of Nos. 2a and 3 Marie Close	for a distance of 30 metres in a northerly then north-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of September of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Marie Close/Chloe Gardens) (Amendment No. 74) Order 2011.
