

**BOROUGH OF POOLE**  
**THE POOLE (TRAFFIC MANAGEMENT)**  
**(BRYANT ROAD, CHANDOS AVENUE, HEATHFIELD AVENUE) (AMENDMENT NUMBER 84) ORDER 2011**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 3(2), 4(1), 4(2), and (5), 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

**A. The following shall be added to Schedule No. 5.01 (No Waiting at any Time) to the Order:**

i	Bryant Road	north west side	from the common boundary of Nos. 39 Chandos Avenue and No. 34 Bryant Road	to the common boundary of Nos. 36 and 38 Bryant Road
ii	Bryant Road	south east side	from the common boundary of Nos. 33 and 35 Bryant Road	to the common boundary of Nos. 39 Bryant Road and 44 Heathfield Avenue

i	Chandos Avenue	both sides	from its junction with Bryant Road	for a distance of 10 metres in a north-westerly direction
ii	Chandos Avenue	both sides	from the common boundary of Nos. 31 and 35 Chandos Avenue	for a distance of 38 metres, measured along the centreline of the carriageway, in a south-westerly then south-easterly direction

i	Heathfield Avenue	both sides	from its junction with Bryant Road	for a distance of 10 metres in a south-easterly direction
ii	Heathfield Avenue	north west side	from the common boundary of Nos. 33 and 35 Heathfield Avenue	for distance of 37 metres, measured along the centreline of the carriageway, in a south-westerly then north-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of November of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Bryant Road, Chandos Avenue and Heathfield Avenue) (Amendment No. 84) Order 2011.
