

## BOROUGH OF POOLE

### THE POOLE (TRAFFIC MANAGEMENT) (BROADMAYNE ROAD) (AMENDMENT NUMBER 85) ORDER 2011

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 3(2), 4(1), 4(2), and (5), 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

**A. The following shall be added to Schedule No. 5.01 (No Waiting at any Time) to the Order:**

i	Bloxworth Road	south west side	from the common boundary of Nos. 17 and 19 Bloxworth Road	to the common boundary of Nos. 13 and 15 Bloxworth Road
i	Broadmayne Road	both sides	from its junction with Bloxworth Road	for a distance of 15 metres in a south-westerly direction
ii	Broadmayne Road	north west side	from a point 10 metres north-east of its junction with Slepe Crescent	to a point 10 metres south-west of its junction with Slepe Crescent
iii	Broadmayne Road	south east side	from a point 10 metres south-west of its junction with Broadmayne Road (cul-de-sac Nos. 11 to 33)	to a point 10 metres north-east of its junction with Broadmayne Road (cul-de-sac Nos. 11 to 33)
iv	Broadmayne Road (cul-de-sac Nos. 11 to 33)	both sides	from its junction with Broadmayne Road	for a distance of 10 metres in a south-easterly direction
i	Slepe Crescent	north east side	from its junction with Broadmayne Road	for a distance of 10 metres in a north-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of November of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Broadmayne Road) (Amendment No. 85) Order 2011.
