(DAVIS ROAD, GWYNNE ROAD, LAYTON ROAD, LIBRARY ROAD) (AMENDMENT NUMBER 89) ORDER 2011

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 3(2), 4(1), 4(2), and (5), 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

A. The following shall be added to Schedule No. 5.01 (No Waiting at any Time) to the Order:

| i | Davis Road | east side | from a point 10 metres north-west of its junction with Gwynne Road | south of its junction with Gwynne Road |
| ii | Davis Road | north-east side | from its junction with Library Road | for a distance of 10 metres in a south-easterly direction |
| iii | Davis Road | south-west side | from its junction with Library Road to the common boundary of Nos. 31 and 33 Davis Road | in a south-westerly direction |
| i | Gwynne Road | both sides | from its junction with Davis Road | to the common boundary of Nos. 7 and 9 Gwynne Road |
| ii | Gwynne Road | south side | from its junction with Davis Road | for a distance of 20 metres, measured along the centreline of the carriageway, in an easterly direction |
| i | Layton Road | both sides | from its junction with Library Road | for a distance of 15 metres in a westerly direction |
| i | Library Road | north west side | from the common boundary of Nos. 45a and 47 Library Road | to a point 15 metres south-west of its junction with Davis Road |
| ii | Library Road | south east side | from a point 15 metres north-east of its junction with Davis Road | to a point 15 metres south-west of its junction with Davis Road |

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of November of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Davis Road, Gwynne Road, Layton Road, Library Road) (Amendment No. 89) Order 2011.
