THE POOLE (TRAFFIC MANAGEMENT)
(POOLE PARK) (AMENDMENT NUMBER 99) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 7.08 (On Street Parking Place Maximum Stay Four Hours) from the Order:

i.	Poole Park Drive	north-west side	from a point 93 metres south-west of Park Gates East	for a distance of 33 metres in a south-westerly direction

B. The following shall be deleted from Schedule No. 7.09 (On Street Parking Place Maximum Stay Four Hours Except Permit Holders (Council)) from the Order:

F. The following shall be added to Schedule No. 7.37 (On Street Parking Place 8am-6pm Maximum Stay Three Hours) to the Order:

i.	Poole Park Drive	north-west side	from a point 93 metres south-west of Park Gates East	for a distance of 33 metres in a south-westerly direction
ii	Poole Park Drive	north-west side	from a point 186 metres south-west of Park Gates East	for a distance of 46 metres in a south-westerly direction

G. The following shall be added to Schedule No.10.06 (Off Street Parking Place – Free, Surface, Maximum Stay 3 Hours, 8am-6pm) to the Order:

i.	Poole Park Middle Gates	Plan C43
ii	Poole Park Swan Lake	Plan C42

H. The following shall be added to Schedule No.10.33 (Off Street Parking Place – Free, Surface, Maximum Stay 2 Hours, 8am-6pm) to the Order:

i.	Poole Park Westfield (formally Poole Park Fountain)	Plan C41
