

**BOROUGH OF POOLE
THE POOLE (TRAFFIC MANAGEMENT)
(SANDRINGHAM ROAD/BALMORAL ROAD) (AMENDMENT NUMBER 72i) ORDER 2012**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 4(1), 4(2), 4(3), 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i	Sandecotes Road	west side	from a point 15 metres north of its junction with Balmoral Road	to a point 15 metres south of its junction with Balmoral Road
i	Sandringham Road	north side	from its junction with Osborne Road	to the common boundary of Nos. 17 and 19 Sandringham Road
ii	Sandringham Road	north side	from its junction with Sandecotes Road	to the common boundary of Nos. 37 and 39 Sandringham Road
iii	Sandringham Road	south side	from its junction with Sandecotes Road	to the common boundary of Nos. 10 and 12/14 Sandringham Road

B. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Osborne Road	south side	from the common boundary of Nos. 4 and 6 Osborne Road	to the common boundary of Nos. 8 and 10 Osborne Road
i	Sandecotes Road	west side	from a point 15 metres north of its junction with Osborne Road	to a point 5 metres south of its junction with Osborne Road
i	Sandringham Road	both sides	from its junction with Sandecotes Road	for a distance of 15 metres in a westerly direction
ii	Sandringham Road	north side	from its junction with Osborne Road	to the common boundary of Nos. 11 and 13 Sandringham Road

C. The following shall be added to Schedule 5.09 (No Waiting Mon-Fri 8am-6pm) to the Order:

i	Sandringham Road	north side	from the common boundary of Nos. 11 and 13 Sandringham Road	to the common boundary of Nos. 17 and 19 Sandringham Road
ii	Sandringham Road	south side	from the common boundary of Nos. 10 and 12 Sandringham Road	to a point 15 metres west of its junction with Sandecotes Road

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Fifth Day of March of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Sandringham Road/Balmoral Road) (Amendment No. 72i) Order 2011
