**THE POOLE (TRAFFIC MANAGEMENT)**  
**(BAILEY CRESCENT) (AMENDMENT NUMBER 06) ORDER 2011**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:**

i.	Bailey Crescent	both sides	from its western junction with Wimborne Road	for a distance of 14 metres in a north easterly direction
----	-----------------	------------	--	---

**B. The following shall be added to Schedule No. 5.01 (No Waiting At AnyTime) to the Order:**

i.	Bailey Crescent	north-west side	from its western junction with Wimborne Road	for a distance of 41 metres in a north-easterly direction
ii.	Bailey Crescent	south-east side	from its western junction with Wimborne Road	for a distance of 44 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Fifth Day of March of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Bailey Crescent) (Amendment No. 06) Order 2011
