

## BOROUGH OF POOLE

### THE POOLE (TRAFFIC MANAGEMENT) (WINSTON AVENUE/WINSTON GARDENS) (AMENDMENT NUMBER 07) ORDER 2011

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:**

i.	Winston Avenue	northern side	from opposite a point 15 metres west of its junction with Cornelia Crescent	to the common boundary of Nos. 99 and 101 Winston Avenue

**B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:**

i.	Winston Avenue	north side	from the common boundary of Nos. 71 and 73 Winston Avenue	to the common boundary of Nos. 99 and 101 Winston Avenue

i	Winston Gardens	both sides	from its junction with Winston Avenue	for a distance of 15 metres in a northerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Fifth Day of March of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Winston Avenue/Winston Gardens) (Amendment No. 07) Order 2011
