**THE POOLE (TRAFFIC MANAGEMENT)
(WORTHINGTON CRESCENT) (AMENDMENT NUMBER 75) ORDER 2011**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 4(1), 4(2), 4(3), 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

A. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i	Worthington Crescent	north and west side	from a point opposite the common boundary of Nos. 6 and 7 Worthington Crescent	for a distance of 23 metres in a southerly then westerly direction
ii	Worthington Crescent	west and south side	from the common boundary of Nos. 20 and 21 Worthington Crescent	for a distance of 25 metres in a northerly then westerly direction

B. The following shall be added to Schedule No. 5.09 (No Waiting, Mon-Fri, 8am-6pm)

i	Worthington Crescent	East side	from the common boundary of Nos. 6 and 7 Worthington Crescent in a southerly direction	to a point opposite the common boundary of Nos. 20 and 21 Worthington Crescent

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Eleventh Day of October of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Worthington Crescent) (Amendment No. 75) Order 2011
