

**BOROUGH OF POOLE**  
**THE POOLE (TRAFFIC MANAGEMENT)**  
**(COWSLIP ROAD) (AMENDMENT NUMBER 78) ORDER 2011**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 3(2), 4(1), 4(2), and (5), 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

**A. The following shall be added to Schedule No. 5.01 (No Waiting at any Time) to the Order:**

i	Cowslip Road	both sides	from the common boundary of Nos. 65 and 67/69 Cowslip Road	for a distance of 26 metres, measured along the centreline of the carriageway
ii	Cowslip Road	both sides	from the common boundary of Nos. 74 and 76 Cowslip Road	for a distance of 30 metres in a south-easterly direction
iii	Cowslip Road	both sides	from a point opposite the north-western boundary of Nos. 111 Cowslip Road	for a distance of 10 metres in a north-easterly direction
iv	Cowslip Road (Cul-de-sac Odd Nos. 1 to 41 Cowslip Road)	both sides	from its southern junction with itself (between Nos. 1 and 41 Cowslip Road)	for a distance of 10 metres in a north-westerly direction
v	Cowslip Road (Cul-de-Sac Odd Nos. 1 to 41 Cowslip Road)	both sides	from its south-westerly extremity	for a distance of 20 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of November of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Cowslip Road) (Amendment No. 78) Order 2011.
