**THE POOLE (TRAFFIC MANAGEMENT)  
(LEAROYD ROAD) (AMENDMENT NUMBER 101) ORDER 2011**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 4(1), 4(2), 4(3), 5, 26, 28, 63A, 65, 66, 81, 82, 84(1) and (2), 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows

**A. The following shall be added to Schedule No. 5.15 (School Keep Clear, Mon-Fri, 8am-6pm) to the Order:**

i	Learoyd Road	south east side	from opposite a point 9 metres west of its junction with Nettleton Close	for a distance of 28 metres in a south-westerly direction

**B. The following shall be added to Schedule 6.01 (No Loading or Unloading At Any Time)**

i	Adastral Road	west side	from a point 15 metres south of its junction with Learoyd Road	to a point 15 metres north of its junction with Learoyd Road
---	---------------	-----------	--	--

i	Learoyd Road	both sides	from its junction with Adastral Road	for a distance of 14 metres in a westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Thirty-First Day of January of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Learoyd Road) (Amendment No. 101) Order 2011
