(PHP EAST STREET, EAST QUAY ROAD AND PROSPEROUS STREET) (AMENDMENT NUMBER 02) ORDER 2011

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 32, 35, 35(A), 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 11 be amended as follows:

A. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	East Quay Road – Service Area to Numbers 7-31 East Quay Road	both	the entire Service Area to the north-west	of numbers 7-31 East Quay Road
ii	Nelson Court Access Road	both	total length including the Service Area	accessed via East Street
iii	Prosperous Street – PHP Garage Frontage	both	the entire area fronting the PHP Garages	accessed via Prosperous Street

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No.11 shall remain in full force and effect.
3. This Order shall come into operation on the First Day of May of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (PHP East Street, East Quay Road and Prosperous Street) (Amendment No. 02) ORDER 2011
