THE POOLE (TRAFFIC MANAGEMENT)

(NEW ROAD/BEACONSFIELD ROAD/CROMWELL ROAD/BERESFORD ROAD) (AMENDMENT NUMBER 13) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	Beaconsfield Road	both sides	from its junction with Cromwell Road	to the common boundary of Nos. 29 and 31 Beaconsfield Road

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Beaconsfield Road	both sides	from a point 10 metres west of its junction with Beresford Road	to a point 10 metres east of its junction with Beresford Road
ii	Beaconsfield Road	both sides	from a point 51 metres east of its junction with Beresford Road	for a distance of 29 metres measured along the centreline of the road
iii	Beaconsfield Road	both sides	from its junction with Cromwell Road	for a distance of 10 metres in a northerly direction
iv	Beaconsfield Road	north-west side	from its junction with Cromwell Road	to a point 40 metres east of its junction with New Road
v	Beaconsfield Road	south-east side	from the western boundary of No. 9 Beaconsfield Road	for a distance of 36 metres in a south-westerly direction
vi	Beaconsfield Road	south-east side	from its junction with Cromwell Road	to the common boundary of Nos. 29 and 31 Beaconsfield Road

i	Beresford Road	both sides	from its junction with Beaconsfield Road	for a distance of 10 metres in a northerly direction

i	Cromwell Road	both sides	from a point 10 metres west of its junction with Beaconsfield Road	to a point 10 metres east of its junction with Beaconsfield Road
i	New Road	both sides	from its junction with Beaconsfield Road	to the southern boundary of No. 20 New Road

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twelfth Day of June of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (New Road/Beaconsfield Road/Cromwell Road/Beresford Road) (Amendment No. 13) Order 2012
