**THE POOLE (VARIOUS ROADS) (REGULATION OF TRAFFIC MOVEMENT AND SPEED LIMITS)  
(HEATHERLANDS 20 MPH ZONE) (AMENDMENT NUMBER 13A) ORDER 2012**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 4(1), 4(2), 4(3), 5, 26, 28, 63A, 65, 66, 81, 82, 84(1) and (2), 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders made for the Regulation of Vehicle Movements and Speed Limits) Order No. 2 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (20 MPH Speed Limit) from the Order:**

i	Cromwell Road	both sides from its western junction with Beaconsfield Road to a point 120 metres west of its junction with Albert Road.

**B. The following shall be added to Schedule No. 5.01 (20 MPH Speed Limit) to the Order:**

i	Beaconsfield Road	both sides, total length
---	-------------------	--------------------------

i	Cromwell Road	Both sides, total length

i	Heatherlands Rise	both sides, total length
---	-------------------	--------------------------

i	New Road	both sides, total length

2. Save as hereby amended The Poole (Various Roads) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders Made for the Regulation of Traffic Movement and Speed Limits) Order No. 2 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Seventh Day of November of the Year Two Thousand and Twelve and may be cited as: The Poole (Traffic Management) (Heatherlands 20 MPH Zone) (Amendment No. 13A) Order 2012.
