THE POOLE (TRAFFIC MANAGEMENT)
(PRESTON ROAD) (AMENDMENT NUMBER 24) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i	Preston Road	both sides	from its junction with Rectory Road for a distance of 8 metres in a northerly direction	for a distance of 8 metres in a northerly direction (measured along the south eastern side for the road)

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Preston Road	north-west side	from its junction with Rectory Road	for a distance of 10 metres in a north-easterly direction
li	Preston Road	south-east side	from its junction with Preston Road	for a distance of 100 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.

3. This Order shall come into operation on the Twenty Ninth Day of January of the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Preston Road) (Amendment No. 24) Order 2012.
