**THE POOLE (TRAFFIC MANAGEMENT)
(BLANDFORD CLOSE) (AMENDMENT NUMBER 30) ORDER 2010**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	Blandford Close	both sides	total length
----	-----------------	------------	--------------

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Blandford Close	north-east side	from its north-western extremity	for a distance of 24 metres in a south-easterly direction
ii.	Blandford Close	south-east side	from its junction with Blandford Road	for a distance of 85 metres

C. The following shall be added to Schedule No. 5.12 (No Waiting Mon-Fri 8am-10am and 2pm-4pm) to the Order:

i.	Blandford Close	north-east side	from a point 24 metres south-east of its north-western extremity	for a distance of 28 metres in a south-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the First Day of March of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Blandford Close) (Amendment No. 30) Order 2010
