THE POOLE (TRAFFIC MANAGEMENT)
(WORTHINGTON CRESCENT) (AMENDMENT NUMBER 34) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 4(1), 4(2), 4(3) and 5, 32, 33, 35, 35A, 35B, 36, 47, 49, 53, 63A, 65, 66, 89 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from The Borough of Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On-Street and Off-Street Parking Places) Order No. 11:

i	Worthington Crescent	north and west side	from a point opposite the common boundary of Nos. 6 and 7 Worthington Crescent	for a distance of 23 metres in a southerly then westerly direction.

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Worthington Crescent	north and west side	from the rear boundary of No. 4 Worthington Crescent	for a distance of 80 metres in a southerly then westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty Ninth Day of January of the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Worthington Crescent) (Amendment No. 34) Order 2012.
