**THE POOLE (TRAFFIC MANAGEMENT)
(ROSSMORE ROAD, HILDA ROAD, WHARFDALE ROAD) (AMENDMENT NUMBER 36) ORDER 2010**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 3(2), 4(1), 4(2), and (5), 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No. 10 be amended as follows:

A. The following shall be added to Schedule No. 5.01 (No Waiting at any Time) to the Order:

i.	Hilda Road	both sides	from its junction with Rossmore Road	for a distance of 10 metres in a north-easterly direction
i.	Rossmore Road	north-east side	from a point 15 metres north-west of its junction with Hilda Road	to the common boundary between flats 2/4 and 1/3 of 243 Rossmore road
ii.	Rossmore Road	south-west side	from a point 15 metres north-west of its junction with Hilda Road	to a point 15 metres south-east of its junction with Wharfdale Road
i	Wharfdale Road	both sides	from its junction with Rossmore Road	for a distance of 10 metres in a south-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 10 shall remain in full force and effect.
3. This Order shall come into operation on the Fifth Day of April of the Year Two Thousand and Eleven and may be cited as: The Poole (Traffic Management) (Rossmore Road, Hilda Road, Wharfdale Road) (Amendment No. 36) Order 2010.
