

**BOROUGH OF POOLE**  
**THE POOLE (TRAFFIC MANAGEMENT)**  
**(UPPER GOLF LINKS ROAD/DUNYEATS ROAD/LAUREL DRIVE) (AMENDMENT NUMBER 37) ORDER 2012**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:**

i	Dunyeats Road	both sides	from a point 15 metres west of its junction with Upper Golf Links Road	to a point 15 metres east of its junction with Golf Links Road
---	---------------	------------	--	--

i	Laurel Drive	both sides	from its junction with Dunyeats Road	for a distance of 15 metres in a southerly direction
---	--------------	------------	--------------------------------------	--

i	Upper Golf Links Road	both sides	from its junction with Dunyeats Road	for a distance of 15 metres in a northerly direction
---	-----------------------	------------	--------------------------------------	--

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.

3. This Order shall come into operation on the Twenty Eighth Day of February of the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Upper Golf Links Road/Dunyeats Road/Laurel Drive) (Amendment No. 37) Order 2012.
