THE POOLE (TRAFFIC MANAGEMENT) (CHURCHILL GARDENS) (AMENDMENT NUMBER 15A) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i	Churchill Gardens	east side	from its southern extremity	to its northern extremity
ii	Churchill Gardens	west side	from its northern extremity	for a distance of 17 metres in a southerly direction

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Churchill Gardens	east side	from its southern extremity	to its northern extremity
ii	Churchill Gardens	north and west side	from its junction with Churchill Road	to a point 22 metres from its northern extremity
iii	Churchill Gardens	south side	from a point 17 metres from its junction with Churchill Road	for a distance of 24 metres in an easterly direction
iv	Churchill Gardens	south side	from its junction with Churchill Road	for a distance of 10 metres in an easterly direction

v	Churchill Gardens	west side	from its northern extremity	for a distance of 17 metres in a southerly direction
vi	Churchill Gardens	west side	from its southern extremity	for a distance of 13 metres in a northerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Nineteenth Day of March of the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Churchill Gardens) (Amendment No. 15A) Order 2012
