THE POOLE (TRAFFIC MANAGEMENT)
(SALTERNS ROAD) (AMENDMENT NUMBER 20) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(c), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be added to Schedule No. 6.01 (No Loading or Unloading At Anytime) to the Order:

i.	Salterns Road	east side	from its junction with Tennyson Road	for a distance of 38.5 metres in a southerly direction
ii	Salterns Road	east side	from the southern building line of No. 33	for a distance of 5 metres in a southerly direction
iii	Salterns Road	west side	from its junction with Tennyson Road	for a distance of 54 metres in a southerly direction

B. The following shall be added to Schedule No. 7.27 (Loading Bay) to the Order:

i	Salterns Road	east side	from the northern building line of No. 33 Salterns Road	to the southern building line of No. 33 Salterns Road

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
