**THE POOLE (TRAFFIC MANAGEMENT)
(STORY LANE) (AMENDMENT NUMBER 35) ORDER 2012**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order

i	Story Lane	both sides	total length

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Story Lane	north east side	total length	
ii	Story Lane	south west side	from a point 16 metres north-west of the rear common boundary of Nos. 182 and 184a Lower Blandford Road	to its junction with Macaulay Road
iii	Story Lane	west and south side	from its junction with Kirkway	to the common boundary at the rear of Nos. 182 and 184a Lower Blandford Road

C. The following shall be added to Schedule 7.27 (On-Street Parking Place Loading Only) to the Order:

i	Story Lane	south west side	from the rear common boundary of Nos. 182 and 184a Lower Blandford Road	for a distance of 14 metres in a north-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty Eighth Day of February of the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Story Lane) (Amendment No. 35) Order 2012.
