THE POOLE (TRAFFIC MANAGEMENT)
(ALDERNEY AVENUE) (AMENDMENT NUMBER 51) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	Alderney Avenue	north & west side	from its junction with Ringwood Road	for a distance of 15 metres in a south-east direction
ii	Alderney Avenue	north-east side	from a point 15 metres north and west of its junction with Jersey Road	to opposite a point 15 metres south-east of its junction with Manor Avenue

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Alderney Avenue	north-west side	from its junction with Ringwood Road	for a distance of 115 metres in a north-easterly direction
ii.	Alderney Avenue	north-east side	from a point 15 metres north-west of its junction with Jersey Road	to opposite a point 15 metres south-east of its junction with Manor Avenue

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Eighth Day of March the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Alderney Avenue) (Amendment No. 51) Order 2013
