**THE POOLE (TRAFFIC MANAGEMENT)**  
**(VICARAGE ROAD/STANLEY GREEN ROAD) (AMENDMENT NUMBER 54) ORDER 2012**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 3(1), 3(2), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:**

i.	Stanley Green Road	north-east side	from a point 15 metres north-east of its junction with Rectory Road	to the boundary of Nos. 98 and 100 Stanley Green Road

**B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:**

i.	Stanley Green Road	north-west side	from the common boundary of Nos. 98 and 100 Stanley Green Road	to a point 25 metres north of its junction with Rectory Road

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Eighth Day of May the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Vicarage Road/Stanley Green Road) (Amendment No. 54) Order 2013
