THE POOLE (TRAFFIC MANAGEMENT)
(SHERRIN CLOSE) (AMENDMENT NUMBER 66) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 3, 2(1), 2(2C), 2(4), 3(1), 3(2), 4(1), 4(2), 4(3), 5, 32, 33, 35, 35A, 35B, 35C, 36, 45, 46(A), 47, 49, 51, 52, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	Sherrin Close	both sides	from its junction with Mellstock Road	for a distance of 10 metres

B. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i.	Sherrin Close	east side	from a point 48 metres south of its junction with Mellstock Road	to its southern extremity
ii	Sherrin Close	east side	from its junction with Mellstock Road	for a distance of 10 metres
iii	Sherrin Close	west side	total length	

C. The following shall be added to Schedule No. 8.18 (On-Street Parking Place Waiting Limited to Two Hours Mon-Fri 8am-6pm except Permit Holders (Resident)) to the Order:

i	Sherrin Close	east side	from a point 10 metres south of its junction with Mellstock Road	for a distance of 38 metres in a southerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Fifth Day of November the Year Two Thousand and Thirteen and may be cited as: The Poole (Traffic Management) (Sherrin Close) (Amendment No. 66) Order 2013
