THE POOLE (TRAFFIC MANAGEMENT) (TWEMLow AVENUE/ORCHARD AVENUE) (AMENDMENT NUMBER 82) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 2(4), 3(1), 3(2), 4(1), 4(2), 4(3), 5, 26, 28, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66, 81, 82, 84(1), (2), 85(1), (2), (4), (5), 87, 89, 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.19 (No Waiting Mon-Fri 10am-midday or 2pm-4pm) from the Order:

i.	Orchard Avenue	both sides	from a point 23 metres south-west of the common boundary of Nos. 62 and 64 Orchard Avenue	to a point 15 metres south-west of its eastern junction with Twemlow Avenue
ii	Orchard Avenue	both sides	from a point 15 metres south-east of its western junction with Twemlow Avenue	to a point 3 metres south-east of the common boundary of Nos. 64 and 66 Orchard Avenue

i	Twemlow Avenue	both sides	from a point 15 metres north-east of its western junction with Orchard Avenue	to a point 5 metres south-west of the common boundary of Nos. 3 and 5 Twemlow Avenue
ii	Twemlow Avenue	both sides	from the common boundary of Nos. 14 and 16 Twemlow Avenue	to a point 12 metres north-east of its northern junction with Orchard Avenue

B. The following shall be added to Schedule No. 5.22 (No Waiting Mon-Fri 10am-midday or 2pm-4pm, Except Bank Holidays) to the Order:

i.	Orchard Avenue	both sides	from a point 23 metres south-west of the common boundary of Nos. 62 and 64 Orchard Avenue	to a point 15 metres south-west of its eastern junction with Twemlow Avenue
ii	Orchard Avenue	both sides	from a point 15 metres south-east of its western junction with Twemlow Avenue	to a point 3 metres south-east of the common boundary of Nos. 64 and 66 Orchard Avenue

i	Twemlow Avenue	both sides	from a point 15 metres north-east of its western junction with Orchard Avenue	to a point 5 metres south-west of the common boundary of Nos. 3 and 5 Twemlow Avenue
ii	Twemlow Avenue	both sides	from the common boundary of Nos. 14 and 16 Twemlow Avenue	to a point 12 metres north-east of its northern junction with Orchard Avenue

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Eighteenth Day of February of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Twemlow Avenue/Orchard Avenue) (Amendment No. 82) Order 2013.
