**THE POOLE (TRAFFIC MANAGEMENT)
(STERTE AVENUE WEST) (AMENDMENT NUMBER 85) ORDER 2013**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3) and 5, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i.	Sterte Avenue West	both sides	from a point 25 metres north-east of its junction with Holes Bay Road	all sides total length

C. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

D.

i.	Sterte Avenue West	both sides	from a point 25 metres north-east of its junction with Holes Bay Road	all sides total length
ii	Sterte Avenue West	east side	from a point 25 metres north-east of its junction with Holes Bay Road	for a distance of 247 metres in a north easterly direction
iii	Sterte Avenue West	east side	from the entrance of Holes Bay Park	For a distance of 22 metres in a north-easterly direction
iv	Sterte Avenue West	north-east side	from a point 30 metres north-east of the entrance to Holes Bay Park	for a distance of 27 metres to its northern extremity
v	Sterte Avenue West	west side	from a point 25 metres north-east of its junction with Holes Bay Road	to its northern extremity

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Fifth Day of February of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Sterte Avenue West) (Amendment No. 85) Order 2013.
