**THE POOLE (TRAFFIC MANAGEMENT)
(KITCHENER CRESCENT)
(AMENDMENT NUMBER 98) ORDER 2013**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 3(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66, 87 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be added to Schedule No. 6.09 (No Loading or Unloading Mon-Fri 8am-10am and 2pm-4pm) to the Order:

i.	Hastings Road	north side	from its junction with Kitchener Crescent	for a distance of 15 metres in an easterly direction
ii	Hastings Road	south side	from its junction with Kitchener Crescent	for a distance of 23 metres in an easterly direction

i	Kitchener Crescent	east side	from a point 28 metres south of its junction with Hastings Road	to a point 73 metres north of the said junction
ii	Kitchener Crescent	west side	from opposite a point 24 metres south of its junction with Hastings Road	for a distance of 22 metres in a southerly direction

B. The following shall be added to Schedule No. 7.14 (On-Street Parking Place Disabled Persons Parking Only) to the Order:

i	Kitchener Crescent	west side	from opposite the junction of Hastings Road	for a distance of 32 metres in a northern direction

- 2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
- 3. This Order shall come into operation on the Fourth Day of March of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Kitchener Crescent) (Amendment No. 98) Order 2013.
