

## BOROUGH OF POOLE

### THE POOLE (TRAFFIC MANAGEMENT) (NORTH ROAD/COMMERCIAL ROAD) (AMENDMENT NUMBER 103) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 3(1), 3(2), 4(1), 4(2), 4(3), 5, 26, 28, 32, 35, 35a, 36, 47, 49, 53, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 7.27 (Loading Only) from the Order:**

i	North Road	east side	from a point 30 metres north of its western junction with Commercial Road	for a distance of 15 metres in a northerly direction

**B. The following shall be deleted from Schedule No. 8.06 (Waiting Limited to 30 Minutes, Mon-Sat, 8am-6pm) from the Order:**

i	North Road	east side	from a point 25 metres north of its junction with Commercial Road	for a distance of 5 metres in a northerly direction
---	------------	-----------	---	---

**C. The following shall be added to Schedule 5.01 (No Waiting at Any Time) to the Order:**

i	North Road	east side	from a point 30 metres north of its junction with Commercial Road	for a distance of 20 metres in a northerly direction
---	------------	-----------	---	--

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Eighteenth Day of February of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (North Road/Commercial Road) (Amendment No. 103) Order 2013.
