THE POOLE (TRAFFIC MANAGEMENT)
(WINSTON AVENUE) (AMENDMENT NUMBER 81) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(C), 2(4), 3(1), 3(2), 4(1), 4(2), 4(3), 5, 26, 28, 32, 35, 35a, 36, 47, 49, 53, 63A, 65, 66, 81, 82, 84(1), (2), 85(1), (2), (4), (5), 87, 89, 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be added to Schedule No. 6.09 (No Loading or Unloading Mon-Fri 8am-10am and 2pm-4pm) to the Order:

i	Winston Avenue	both	from a point 25 metres west of the centre point of the roundabout adjacent to Bishop Aldhelms school	for a distance of 62 metres north measured from the centre point of the said roundabout and southwards to the school gates
ii	Winston Avenue	north side	from the common boundary of Nos. 89 and 91 Winston Avenue	to the common boundary of Nos. 99 and 101 Winston Avenue
iii	Winston Avenue	south side	from a point 3 metres west of the common boundary of Nos. 62 and 64 Winston Avenue	for a distance of 42 metres in an easterly direction
iv	Winston Avenue	South side	from a point 22 metres west of its junction with Cornelia Crescent	to a point 35 metres east of the said junction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Eighth Day of January of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Winston Avenue) (Amendment No. 81) Order 2013.
