THE POOLE (TRAFFIC MANAGEMENT) (SEA VIEW ROAD BUS INTERCHANGE) (AMENDMENT NUMBER 49) ORDER 2012

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(3), 4(1), 4(2), 4(3), 5, 19, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.06 (On Street Parking Place, Waiting Limited to 30 Minutes, Mon-Sat, 8am-6pm) from the Order:

i	Ashley Road	northern side	from a point 97 metres west of its junction with Chatsworth Road	for a distance of 10 metres in a westerly direction

B. The following shall be added to Schedule No. 9.03 (Bus Stop Clearway) to the Order:

i	Ashley Road	north side	from a point 8 metres from the boundary of No. 636 Ashley Road	for a distance of 26 metres in a north-westerly direction
ii	Ashley Road	south side	from outside No. 543 Ashley Road	for a distance of 26 metres in a south-westerly direction
iii	Constitution Hill Road	east side	from a point 23 metres of its junction with Parkstone Heights	for a distance of 26 metres in a north-easterly direction
iv	Constitution Hill Road	west side	from the common boundary of Nos. 5 and 7 Constitution Hill Road	for a distance of 26 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of April of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Sea View Bus Interchange) (Amendment No. 49) Order 2012.
