

## BOROUGH OF POOLE

### THE POOLE (TRAFFIC MANAGEMENT) (HARWELL ROAD) (AMENDMENT NUMBER 69) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(c), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:**

i	Harwell Road	north-west side	from its south-westerly extremity	for a distance of 15 metres in a north-easterly direction
ii	Harwell Road	north-west side	from opposite a point 40 metres south-west of its junction with Darby’s Lane North	for distance of 20 metres in a south-easterly direction
iii	Harwell Road	south-east side	total length	
iv	Harwell Road	south-west side	total length	

**B. The following shall be deleted from Schedule No. 8.06 (Waiting Limited to 30 Minutes, Mon-Sat, 8am-6pm) from the Order:**

i	Harwell Road	north-east side	from a point 15 metres east of its junction with Nuffield Road	to its junction with Darby’s Lane North

**C. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:**

i	Harwell Road	south-west side	from its junction with Nuffield Road	for a distance of 148 metres in a south-easterly direction

**D. The following shall be added to Schedule No. 5.15 (School Keep Clear, Mon-Fri, 8am-6pm) to the Order:**

i	Harwell Road	south-east side	from 10 metres north of the cycleway/footpath	to 10 metres south of the cycleway/footpath leading to Learoyd Road

**E. The following shall be added to Schedule No. 6.01 (No Loading or Unloading at Any Time) to the Order:**

i	Harwell Road	north-east side	from a point 132 metres east of its junction with Nuffield Road	for a distance of 34 metres in a north-westerly direction
---	--------------	-----------------	-----------------------------------------------------------------	-----------------------------------------------------------

ii	Harwell Road	south-east side	from a point 222 metres from the turning head	to its junction with Darby's Lane North
iii	Harwell Road	south-west side	from a point 148 metres from its junction with Nuffield Road	for a distance of 34 metres in a south-easterly direction

**F. The following shall be added to Schedule No. 8.06 (Waiting Limited to 30 Minutes, Mon-Sat, 8am-6pm) to the Order:**

i	Harwell Road	north-east side	from a point 15 metres east of its junction with Nuffield Road	for a distance of 132 metres in a northerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of April of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Harwell Road) (Amendment No. 69) Order 2013.
