(MUNICIPAL ROAD) (AMENDMENT NUMBER 88) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its powers under Section 1(1), 1(3), 1(3A), 3, 2(1), 4(1), 4(2), 4(3), 5, 10, 11, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and 90(A) of the Highways Act 1980 and Schedule 5 of the Local Authorities' Traffic Regulation Orders (Procedures) (England and Wales) Regulations 1996 and of all other enabling powers and after consultation with the Chief Officer or Police in accordance with paragraph 20 of Schedule 9 to the Road Traffic Regulations Act 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be added to Schedule No. 7.41 (Car Club - Permit Holders Only) to the Order:

i.	Municipal Road	north-west side	from a point 15 metres from its junction with Sandbanks Road	for a distance of 26 metres in a north-easterly direction

B. The following shall be added to Schedule No. 6.01 (No Loading or Unloading at Any Time) to the Order:

i.	Municipal Road	both sides	from its junction with Sandbanks Road	for a distance of 15 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.

3. This Order shall come into operation on the Eighth Day of July of the Year Two Thousand and Fourteen and may be cited as:
The Poole (Traffic Management) (Municipal Road) (Amendment No. 88) Order 2013.
