

## BOROUGH OF POOLE

### THE POOLE (VARIOUS ROADS) (REGULATION OF TRAFFIC MOVEMENT AND SPEED LIMITS) (POOLE ROAD/LINDSAY ROAD/ST ALDHELMS ROAD) (AMENDMENT NUMBER 107) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(3), 3(1), 4(1), 4(2), 4(3), 5, 63A, 65, 66, 81, 82, 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders made for the Regulation of Vehicle Movements and Speed Limits) Order No. 2 be amended as follows:

**A. The following shall be added to Schedule No. 3.02 (Cycleway) to the Order:**

i	Lindsay Road	shared cycleway/footway 25 metres from the junction of St Aldhelm’s Road	for a distance of 20 metres in an easterly direction on Lindsay Road
i	Poole Road	shared cycleway/footway from its junction with St. Aldhelm’s Road	for a distance of 38 metres in a westerly direction
i	St Aldhelm’s Road	shared cycleway/footway 78 metres from its junction with Poole Road	for a distance of 40 metres into Lindsay Road

2. Save as hereby amended The Poole (Various Roads) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders Made for the Regulation of Traffic Movement and Speed Limits) Order No. 2 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of April of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Poole Road/Lindsay Road/St Aldhelms Road) (Amendment No. 107) Order 2013.
