

## BOROUGH OF POOLE

### THE POOLE (TRAFFIC MANAGEMENT) (CRICHEL MOUNT ROAD) (AMENDMENT NUMBER 112) ORDER 2014

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:**

i	Crichel Mount Road	north-west side	from its junction with Sandbanks Road	for a distance of 70 metres in a north-easterly direction

**B. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:**

i	Crichel Mount Road	east side	from its junction with Minterne Road	for a distance of 22 metres in a southerly direction
ii	Crichel Mount Road	east side	from its junction with Minterne Road	for a distance of 22 metres in a north-easterly direction
iii	Crichel Mount Road	north-west side	from its junction with Sandbanks Road	for a distance of 225 metres in a north-easterly direction

i	Minterne Road	south side	from its junction with Crichel Mount Road	for a distance of 15 metres in a south-easterly direction
li	Minterne Road	north side	from its junction with Crichel Mount Road	for a distance of 15 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Ninth Day of April of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Crichel Mount Road) (Amendment No. 112) Order 2014.
