**THE POOLE (TRAFFIC MANAGEMENT)
(BURTON ROAD/BALCOMBE ROAD) (AMENDMENT NUMBER 120) ORDER 2014**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	Burton Road	west side	from a point 73 metres south of its junction with Lindsay Road	to a point 148 metres south of that junction
ii	Burton Road	west side	from a point 223 metres south of its junction with Lindsay Road	to a point 310 metres south of that junction

B. The following shall be deleted from Schedule No. 8.19 (On Street Parking Place Waiting Limited to Two Hours Mon-Fri 8am-6pm Except Permit Holders (Residents) and Season Ticket Holders

i	Burton Road	west side	from a point 148 metres south of its junction with Lindsay Road	to a point 223 metres south of that junction (Zone K)

C. The following shall be added to Schedule No. 5.01 (No Waiting At Any Time) to the Order:

i	Burton Road	west side	from a point 218 metres south of its junction with Lindsay Road	for a distance of 312 metres south of that junction
ii	Burton Road	west side	from a point 73 metres south of its junction with Lindsay Road	to a point 155 metres south of that junction

D. The following shall be added to Schedule No. 8.19 (On Street Parking Place Waiting Limited to Two Hours Mon-Fri 8am-6pm Except Permit Holders (Residents) and Season Ticket Holders

i	Burton Road	west side	from a point 155 metres south of its junction with Lindsay Road	to a point 218 metres south of that junction (Zone K)

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Fifteenth Day of July of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Burton Road/Balcombe Road) (Amendment No. 120) Order 2014.
