THE POOLE (TRAFFIC MANAGEMENT)
(SELDOWN LANE) (AMENDMENT NUMBER 126) ORDER 2014

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 19, 32, 35, 35A, 36, 47, 49, 53, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 8.09 (On Street Parking Place Waiting Limited to One Hour Except Permit Holders (Residents)) from the Order:

i	Seldown Lane	north side	from its junction with Seldown Road	for a distance of 11 metres in a north-easterly direction
ii	Seldown Lane	south side	from a point 66 metres east of its junction with Seldown	for a distance of 30 metres in an easterly direction

B. The following shall be added to Schedule 8.25 (On Street Parking Place Waiting Limited to Two Hours Except Permit Holders (Residents)) to the Order:

i	Seldown Lane	north side	from its junction with Seldown Road	for a distance of 11 metres in a north-easterly direction
ii	Seldown Lane	south side	from a point 66 metres east of its junction with Seldown	for a distance of 30 metres in an easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.

3. This Order shall come into operation on the Twelfth Day of August of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Seldown Lane) (Amendment No. 126) Order 2014.
