**THE POOLE (TRAFFIC MANAGEMENT)**  
**(SANDBANKS ROAD) (AMENDMENT NUMBER 71A) ORDER 2013**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2c), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. Paragraph 2.1.4 shall be added to Part 2 – Waiting, Loading and Unloading Provisions**

**B. The following Schedule shall be added to the Order:**

**Schedule No. 11.01 (No Stopping on the Footway)**

i.	Sandbanks Road	east side	the entire footway from its junction with Salterns Road	to its junction with Pottery Road
i	Salterns Road	east side	the entire footway from the common boundary of Nos. 87 and 89	to its junction with Sandbanks Road
i	Pottery Road	north side	the entire footway from its junction with Sandbanks Road	for a distance of 19 metres in an easterly direction

**C. The following shall be added to Schedule No. 6.01 (No Loading or Unloading At Any Time) to the Order:**

ii	Salterns Road	east side	from its junction with Sandbanks Road	to the boundary of Nos. 87 and 89

**D. The following shall be added to Schedule No. 8.06 (Waiting Limited to 30 Minutes, Mon-Sat, 8am -6pm) to the Order:**

i.	Salterns Road	east side	from outside No. 77	to outside No. 79
----	---------------	-----------	---------------------	-------------------

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Second Day of September of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Sandbanks Road) (Amendment No. 71A) Order 2013.
