**THE POOLE (TRAFFIC MANAGEMENT)
(POOLE ROAD) (AMENDMENT NUMBER 113A) ORDER 2014**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2C), 2(3), 2(4), 3(1), 4(1), 4(2), 4(3), 5, 19, 23, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:
