The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 19, 32, 35, 35A, 36, 47, 49, 53, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.26 (Taxi Clearway Mon-Sun 6pm-8am On Street Parking Place Road Train Halt Mon-Sun 8am-6pm) from the Order:**

i	The Quay	northern side	from a point 15 metres east of its junction with Fisherman’s Road	for a distance of 25 metres in an easterly direction

**B. The following shall be added to Schedule No. 5.24 (Taxi Clearway) to the Order:**

i	The Quay	northern side	from a point 15 metres east of its junction with Fisherman’s Road	for a distance of 25 metres in an easterly direction

3. This Order shall come into operation on the Twelfth Day of August of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (The Quay) (Amendment No. 123) Order 2014.
