THE POOLE (TRAFFIC MANAGEMENT) (WINDSOR ROAD/ALTON ROAD) (AMENDMENT NUMBER 127) ORDER 2014

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 19, 32, 35, 35A, 36, 47, 49, 53, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 5.18 (No Waiting Mon-Fri 8am-10am and 2pm-4pm Except 24 July to 30 August) from the Order:

i	Alton Road	both sides	from a point 10 metres north-west of its junction with Windsor Road	to a point 10 metres south-east of that junction
ii	Windsor Road	both sides	from a point 10 metres south-west of its junction with Alton Road	to a point 10 metres north-east of that junction

B. The following shall be added to Schedule 5.01 (No Waiting at Any Time) to the Order:

i	Alton Road	both sides	from its junction with Windsor Road	for a distance of 15 metres in a south-easterly direction
ii	Alton Road	northern side	from its junction with Windsor Road	for a distance of 30 metres in a north-westerly direction
iii	Alton Road	southern side	from its junction with Windsor Road	for a distance of 15 metres in a south-westerly direction

i	Windsor Road	both sides	from a point 10 metres south-west of its junction with Alton Road	to a point 15 metres north-east of that junction

C. The following shall be added to Schedule 6.01 (No Loading or Unloading at Any Time) to the Order:

i	Alton Road	both sides	from its junction with Windsor Road	for a distance of 15 metres in a south-easterly direction
ii	Alton Road	northern side	from its junction with Windsor Road	for a distance of 30 metres in a north-westerly direction
iii	Alton Road	southern side	from its junction with Windsor Road	for a distance of 15 metres in a south-westerly direction

i	Windsor Road	both sides	from a point 10 metres south-west of its junction with Alton Road	to a point 15 metres north-east of that junction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Twelfth Day of August of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Windsor Road/Alton Road) (Amendment No. 127) Order 2014.
