

**THE POOLE (TRAFFIC MANAGEMENT)  
(ROSEMARY ROAD) (AMENDMENT NUMBER 139) ORDER 2014**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.13 be amended as follows:

**A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:**

i	Rosemary Road	northern side	from a point 20 metres west of its junction with Maureen Close	to a point 14 metres east of its junction with Rosemary Gardens

**B. The following shall be deleted from Schedule No. 8.20 (Waiting Limited to Two Hours, Mon-Sat, 8am-6pm) from the Order:**

i	Rosemary Road	northern side	from a point 14 metres east of its junction with Ringwood Road	to a point 20 metres west of its junction with Maureen Close

**C. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:**

i	Rosemary Road	northern side	from a point 36 metres west of its junction with Maureen Close	to a point 14 metres east of its junction with Rosemary Gardens

**D. The following shall be added to Schedule No. 8.20 (Waiting Limited to Two Hours, Mon-Sat, 8am-6pm) to the Order:**

i	Rosemary Road	northern side	from a point 18 metres east of its junction with Ringwood Road	to a point 35 metres west of its junction with Maureen Close

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 13 shall remain in full force and effect.
3. This Order shall come into operation on the Sixteenth Day of December of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Rosemary Road) (Amendment No. 139) Order 2014.
