

**THE POOLE (TRAFFIC MANAGEMENT)
(STANLEY ROAD) (AMENDMENT NUMBER 167) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	Stanley Road	both sides	from its junction with Green Road	for a distance of 14 metres in a south-westerly direction

A. The following shall be deleted from Schedule No. 8.15 (On Street-Parking Place Waiting Limited to Two Hours, 8am-6pm, Except Permit Holders, 6pm-8am Permit Holders Only) from the Order:

i	Stanley Road	both sides	from a point 24 metres north-east of its junction with Ballard Road	to a point 14 metres south-west of its junction with Green Road

B. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Stanley Road	both sides	from its junction with Green Road	for a distance of 19 metres in a south-westerly direction

C. The following shall be added to Schedule No. 7.14 (On Street Parking Place Disabled Persons Parking Only) to the Order:

i	Stanley Road	south side	from a point 20 metres south-west of its junction with Green Road	for a distance of 6.6 metres in a westerly direction

D. The following shall be added to Schedule No. 8.15 (On Street-Parking Place Waiting Limited to Two Hours, 8am-6pm Except Permit Holders, 6pm-8am Permit Holders Only) to the Order:

i	Stanley Road	north side	from a point 24 metres north-east of its junction with Ballard Road	to a point 20 metres south-west of its junction with Green Road
---	--------------	------------	---	---

ii	Stanley Road	south side	from a point 24 metres north-east of its junction with Ballard Road	to a point 26 metres south-west of its junction with Green Road.

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.

3. This Order shall come into operation on the Fourteenth Day of July of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (Stanley Road) (Amendment No. 167) Order 2015.
