

**THE POOLE (TRAFFIC MANAGEMENT)  
(SLIP WAY) (AMENDMENT NUMBER 134) ORDER 2014**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.13 be amended as follows:

**A. The following shall be deleted from Schedule No. 7.01 (Unlimited Waiting) from the Order:**

i	Slip Way	north-east side	from a point 65 metres north-west of its junction with West Quay Road	for a distance of 21 metres in a north-westerly direction
ii	Slip Way	south-west side	from a point 71 metres north-west of its junction with West Quay Road	for a distance of 5 metres in a north-westerly direction

**B. The following shall be added to Schedule No. 8.26 (Waiting Limited to Two Hours, 8am-6pm, Except Permit Holders) to the Order:**

i	Slip Way	north-east side	from a point 65 metres north-west of its junction with West Quay Road	for a distance of 21 metres in a north-westerly direction
ii	Slip Way	south-west side	from a point 71 metres north-west of its junction with West Quay Road	for a distance of 5 metres in a north-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 13 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-First Day of October of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Slip Way) (Amendment No. 134) Order 2014.
