

**THE POOLE (TRAFFIC MANAGEMENT)
(ST PETER'S ROAD) (AMENDMENT NUMBER 169) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	St Peter's Road	both sides	from its junction with North Road	to a point 14 metres north-west of its junction with Charmouth Grove

B. The following shall be deleted from Schedule No. 8.19 (On-Street Parking Place Waiting Limited to Two Hours, Mon-Fri, 8am-6pm except Permit Holders) from the Order:

i	St Peter's Road	west side	from a point 14 metres north of its junction with Danecourt Road	to opposite a point 14 metres north of its junction with Charmouth Grove (Zone H)

C. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	St Peter's Road	west side	from its junction with North Road	to a point 14 metres north-west of its junction with Charmouth Grove
ii	St Peter's Road	west side	from a point 102 metres north of its junction with Danecourt Road	for a distance of 15 metres in a northerly direction
iii	St Peter's Road	west side	from a point 121 metres north of its junction with Danecourt Road	for a distance of 6 metres in a northerly direction
iv	St Peter's Road	west side	from a point 133 metres north of its junction with Danecourt Road	for a distance a distance of 11 metres in a northerly direction
v	St Peter's Road	west side	from a point 149 metres north of its junction with Danecourt Road	for a distance of 10 metres in a northerly direction
vi	St Peter's Road	west side	from a point 165 metres north of its junction with Danecourt Road	to its junction with North Road
vii	St Peter's Road	west side	from a point 75 metres north of its junction with Danecourt Road	for a distance of 22 metres in a northerly direction

D. The following shall be added to Schedule No. 8.19 (On Street Parking Place Waiting Limited to Two Hours, Mon-Fri, 8am-6pm, Except Permit Holders (Residents) and Season Ticket Holders) to the Order:

i	St Peter's Road	west side	from a point 116 metres north of its junction with Danecourt Road	for a distance of 6 metres in a northerly direction
ii	St Peter's Road	west side	from a point 127 metres north of its junction with Danecourt Road	for a distance of 6 metres in a northerly direction
iii	St Peter's Road	west side	from a point 144 metres north of its junction with Danecourt Road	for a distance of 6 metres in a northerly direction
iv	St Peter's Road	west side	from a point 159 metres north of its junction with Danecourt Road	for a distance of 6 metres in a northerly direction
v	St Peter's Road	west side	from a point 96 metres north of its junction with Danecourt Road	for a distance of 6 metres in a northerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
3. This Order shall come into operation on the Eighteenth Day of August of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (St Peter's Road) (Amendment No. 169) Order 2015.
