

**THE POOLE (TRAFFIC MANAGEMENT)
(WEST STREET) (AMENDMENT NUMBER 174) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting at Any Time) from the Order:

i	West Quay Road	north-west side	from its junction with The Quay/West Quay Road	to a point 53 metres north-east of its junction with Bay Hog Lane

B. The following shall be deleted from Schedule No. 6.01 (No Loading or Unloading at Any Time) from the Order:

i	West Quay Road	south-east side	total length

C. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	West Street	north-west side	from a point 152 metres from its junction with The Quay/West Quay Road	to a point 53 metres north-east of its junction with Bay Hog Lane
ii	West Street	north-west side	from its junction with The Quay/West Quay Road	for a distance of 85 metres in a north-easterly direction

D. The following shall be added to Schedule No. 6.01 (No Loading or Unloading at Any Time) to the Order:

i	West Street	north-west side	from a point 152 metres from its junction with The Quay/West Quay Road	to a point 53 metres north-east of its junction with Bay Hog Lane
ii	West Street	north-west side	from its junction with The Quay/West Quay Road	for a distance of 85 metres in a north-easterly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
3. This Order shall come into operation on the Sixth Day of October of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (West Street) (Amendment No. 174) Order 2015.
