

**THE POOLE (TRAFFIC MANAGEMENT)
(ST ALDHELM'S ROAD/LINDSAY ROAD) (AMENDMENT NUMBER 182) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be added to Schedule No. 6.01 (No Loading or Unloading at any Time) to the Order:

i	Lindsay Road	north side	from a point 15 metres north-west of its junction with St Aldhelm's Road	to a point 15 metres north-east of said junction
ii	St Aldhelm's Road	west side	from a point 14 metres south of its junction with Lindsay Road	to its junction with Poole Road

B. The following shall be added to Schedule No. 6.03 (No Loading or Unloading, Mon-Sat, 8am-6pm) to the Order:

i	St Aldhelm's Road	east side	from a point 14 metres south of its junction with Lindsay Road	to a point 14 metres north of its junction with Lindsay Road

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
3. This Order shall come into operation on the Twenty-Fifth Day of August of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (St Aldhelm's Road/Lindsay Road) (Amendment No. 182) Order 2015.
