

**THE POOLE (TRAFFIC MANAGEMENT)
(STERTE CLOSE) (AMENDMENT NUMBER 172) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be deleted from Schedule No. 5.07 (No Waiting, Mon-Sat, 8am-6pm) from the Order:

i	Sterte Close	northern side	from a point 43 metres south-west of its junction with Sterte Road	for a distance of 101 metres in a southerly direction measured along the centre line of the road

B. The following shall be added to Schedule 5.01 (No Waiting at Any Time) to the Order:

i	Sterte Close	northern side	from a point 109 metres south-west of its junction with Sterte Road	for a distance of 30 metres to outside No. 28 Sterte Close

C. The following shall be added to Schedule 5.07 (No Waiting, Mon-Sat, 8am-6pm) to the Order:

i	Sterte Close	Northern side	From a point 43 metres south-west of its junction with Sterte Road	For a distance of 66 metres in a southerly direction measured along the centre line of the road

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.

3. This Order shall come into operation on the Eighteenth Day of August of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (Sterte Close) (Amendment No. 172) Order 2015.
