

**THE POOLE (TRAFFIC MANAGEMENT)
(OAKLEY STRAIGHT) (AMENDMENT NUMBER 179) ORDER 2015**

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 4(1), 4(2), 4(3), 5, 32, 35, 35A, 36, 47, 49, 53, 63A, 65 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.12 be amended as follows:

A. The following shall be deleted from Schedule No. 5.01 (No Waiting At Any Time) from the Order:

i	Oakley Straight	both sides	from its junction with Merley Lane	to a point 10 metres north of its junction with Sopwith Crescent
---	-----------------	------------	------------------------------------	--

B. The following shall be added to Schedule No. 5.01 (No Waiting at Any Time) to the Order:

i	Oakley Straight	east side	from its junction with Merley Lane	to its junction with Sopwith Crescent
ii	Oakley Straight	east side	from its junction with Sopwith Crescent	for a distance of 25 metres in a northerly direction
iii	Oakley Straight	west side	from its junction with Merley Lane	to a point 10 metres north of its junction with Sopwith Crescent

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 12 shall remain in full force and effect.
3. This Order shall come into operation on the Eighteenth Day of August of the Year Two Thousand and Fifteen and may be cited as: The Poole (Traffic Management) (Oakley Straight) (Amendment No. 179) Order 2015.
